2018 Summer Financial Aid Request Form

To apply for financial aid for the summer session of 2018, you must have a 2017-2018 Free Application for Federal Student Aid (FAFSA) application on file by June 30, 2018. You **MUST SUBMIT** this Summer Financial Aid Request Form by **April 27, 2018** if you plan to use Financial Aid to cover your summer courses. Any forms submitted after April 27, 2018 may not be processed before the summer payment deadline. **IF YOUR REGISTRATION STATUS CHANGES YOU MUST NOTIFY THE OFFICE OF FINANCIAL AID IMMEDIATELY!**

Should you qualify, you will be considered for any additional available grant funds. If you have exhausted all of your Federal Direct Stafford Loan funds during the 2017-2018 academic year, you will need to consider applying for a William D. Ford Federal Direct Parent PLUS Loan or a Private/Alternative Loan. (Please refer to [the DSU website](#) for information and instructions concerning the [William D. Ford Federal Direct Parent PLUS Loan and Private/Alternative Loans](#).) Loan funds **may** be available through the [William D. Ford Federal Direct Stafford Loan](#) program if you did not utilize all of your eligibility during the fall 2017 and spring 2018 semesters.
